3. The payment of the balance amount shall be made within ten (10) working days from the date of acceptance, failing which the offer will be cancelled and the 25% payment deposit shall be forfeited along with the earnest money deposit.

4. The successful bidder shall be allowed to lift the vehicle(s) only after making the

full payment.

5. The earnest money deposit of the unsuccessful bidders shall be refunded immediately after the completion of the tender.

6. The earnest money deposit of the successful bidder will be forfeited if the bidder

refuses to accept the tender.

7. The submission of the tender shall mean that the bidders have inspected the vehicles physically and have quoted the rate. Any complaints on the condition of the vehicle shall not be entertained at any cost later.

8. The successful bidder shall ensure that the Ownership transfer of vehicle is

executed within 15 days as per the existing RSTA Rules & Regulation.

9. The ownership transfer cost/tax and any other vehicle related cost shall be borne by the successful bidder.

10. If the offered price is found less than the reserve price of the vehicle, the bid shall remain cancelled or the FCBL Management shall decide as deemed necessary.

11. The committee shall open the bids received and read out the quoted bid amount to the participants.

12. If there is a tie between bidders then a lucky draw shall be held as "YES" to decide the ultimate winner or the successful bidder.

13. The sum of Nu.500/- per day shall be imposed for the delay of the lift of the vehicle from the station.

14. A copy of the CID card shall be submitted along with the bid.

15. The tender committee reserves the right to accept or reject the bids without assigning any reason whatsoever.

16. All the bidders shall sign this document confirming their quoted rates and agreement to the terms and conditions stipulated herein.
